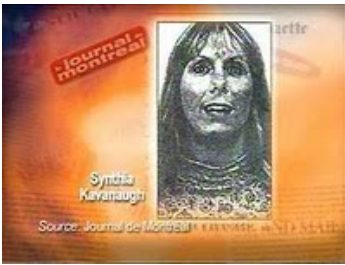

## **Violent Transexual Shipped Out Killer Transexual From Jail after Threatening Staff**

A Toronto transsexual killer who was given sex toys while at an Edmonton women's prison has been transferred from the jail after threatening staff and vandalizing the building. Synthia Kavanagh -- who made national headlines after winning the right to have a sex-change operation while in prison -- was sent last week to the Grand Valley Institution for Women in Kitchener from the Edmonton Institution for Women, sources say.

A spokesman for Correctional Service of Canada declined to comment on the matter. Kavanagh was sentenced to life in prison with no chance of parole for 25 years for the 1987 hammer slaying in Toronto of a transsexual prostitute, Leo James Black, 23, also known as Lisa Janna Black. Kavanagh, 43, was born Richard Chaperon and was also known as Richard Kavanagh.

During her stay at the Edmonton institution, Kavanagh was given a sex toy for "medical purposes," said a prison source. "I see our government bending over backwards to accommodate the interests of prisoners and forgetting the entire role of prisons is to protect society and to reform some prisoners," said Conservative justice critic Vic Toews.

'Sex reassignment'

"What it appears to me is the government is trying to accommodate the interests of the prisoner and, quite frankly, forgetting the interests of taxpayers." Cathy Stocki of the Correctional Service of Canada said the agency changed its policy in 2001 to pay for "sex-reassignment surgery" in those cases where it is considered essential by a gender-identity expert. Follow-up medical assistance is provided if it's considered essential.

In 1999, Kavanagh complained to the Canadian Human Rights Commission that she was being discriminated against on the grounds of disability and sex because she was denied hormone therapy and a sex change. The complaint was settled, and CSC revised its health policies to allow the surgery for prisoners who meet certain criteria. The department also made hormone treatment more readily available. Her victory was called a landmark decision. Toews said while taxpayers are ready to fund corrections, they want the government to focus on the key goals of jails, which are to rehabilitate prisoners and detain them.

Kevin Grabowsky of the Union of Canadian Correctional Officers said that Kavanagh's case illustrates that the correctional service needs to create a special handling unit for violent female offenders, as there is for men.

In Edmonton, violence in a women's prison has exploded with the decision to house a male prisoner within its walls:

Synthia Kavanagh is in the midst of a 25 year sentence, the maximum under Canadian law, for the 1987 hammer slaying of a transsexual prostitute in Toronto.

Kavanagh allegedly trashed the Edmonton's women's prison, fought off guards and threatened the lives of others. She has been moved to the Grand Valley Institution for Women in Kitchener, Ontario.

Didn't I say a man was at the root of the trouble?

Kavanagh won a landmark ruling in 2001 when the Federal Court of Canada ordered Corrections Canada to remove her from a men's prison, house her in a women's facility and pay for her sex reassignment surgery.

"If the medical opinion is that sex reassignment surgery is an essential service for a particular inmate, it follows that it should be paid for by Correctional Services Canada, as would any other essential medical service," wrote Madam Justice Carolyn Layden-Stevenson in her ruling.

The decision forced the government to pay for sex reassignment surgery for any transsexual behind bars who wanted it.

**The problem is, of course, Sylvia Kavanagh is still a man.**

Men who undergo sex reassignment are not re-sized to be women. They generally retain the muscle-mass and build of a man, though that is often traded for weight gain as a side effect of androgen deprivation, which means either being overweight or compensating with exercise. Worse than that, though, is the development of depression and migraines because of the estrogen

therapy.

Oh yeah, facial hair, if already present, is only slightly affected by anti-androgens, requiring constant trimming or electrolysis.

So thanks to what has to be an incredibly bizarre decision from one of our jurists (and we know they are chosen based on their loyalty to the Liberal Party, and not on their wisdom, and yes, Judge Layden-Stevenson is a Liberal Party supporter), Corrections Canada was forced to put an overweight depressed muscle-bound bearded lady in a women's prison, and shockingly, violence ensued.

Now Kavanagh will probably have her sentence extended, and will have to spent it in a high security facility. She won't be alone though. She'll be allowed to take her sex toy with her, provided to her at taxpayers' expense for "therapeutic purposes".

Synthia Kavanagh was sentenced as Ricky Chaperon. As mentioned, he used a hammer to bludgeon a prostitute to death. That prostitute was his lover, a transvestite named Leo Black, aka Lisa Black.

Clearly Ricky had gender issues. So why was the operation considered essential? Did Ricky require plastic surgery because of some injury, or did he suffer from some kind of genital deformity?

Of course not. He was diagnosed with "gender dysphoria", which means he convinced a doctor that he believed he was the wrong sex. Like any psychological problem, there is nothing objective in the diagnosis:

- \* There must be evidence of a strong and persistent cross-gender identification.
- \* This cross-gender identification must not merely be a desire for any perceived cultural advantages of being the other sex.
- \* There must also be evidence of persistent discomfort about one's assigned sex or a sense of inappropriateness in the gender role of that sex.
- \* The individual must not have a concurrent physical intersex condition (e.g., androgen insensitivity syndrome or congenital adrenal hyperplasia).
- \* There must be evidence of clinically significant distress or impairment in social, occupational, or other important areas of functioning.

The fourth criteria is great -- it demands that there is no physical manifestation of gender confusion. But I like the last criteria in particular. Ricky was a convicted killer. I guess that counts as an impairment in an important area of social functioning.

That area of not whacking people.

But then I'm not a learned doctor or wise judge. And thankfully, I'm not a female inmate forced to share space with Ricky aka Synthia, or a guard required to keep order.

## Synthia Kavanagh Human Rights Case

Discrimination is nothing new for transgendered inmates. The injustice starts as soon as they are taken into custody. The debate as to where to place transgendered people often leads to them being placed with those of the sex that they don't identify with or in solitary confinement for their own protection. This is especially an issue when the prisoner is pre-operative. There have been many cases of transgendered prisoners fighting this human rights violation.

One of the most publicized cases in Canada is the Synthia Kavanagh Human Rights Case (<http://www.chrt-tcdp.gc.ca/>). Synthia Kavanagh was born a man but has been living as a woman since the age of 13. She legally changed her name from Ricky at the age of 19. When Synthia was arrested in 1989, she had already begun the process of her transition. When sentenced to life imprisonment for murder, Synthia was taking hormone therapy in preparation for sex reassignment surgery. The judge on her case recommended that she be placed in a female prison; nevertheless Corrections Canada put her in a male institution, and restricted her hormone dosage which started to reverse the physical changes she had already endured. She was repeatedly denied her request for SRS. Distraught Synthia attempted to cut off her penis, and spent years in segregation after being harassed, taunted and sexually assaulted in the general population (<http://www.prisonjustice.ca/>).

Kavanagh filed a complaint with human rights arguing that the Canadian government had an obligation to provide her with adequate medical care, including sex reassignment surgery. As well she filed for the right to be placed in a female prison. She was successful in both her claims. The Canadian Human Rights Tribunal agreed that the current policy of housing male to female transgendered prisoners among the male population was discriminatory. They required Corrections Canada to start assessing transgendered inmates and their housing needs individually with an expert doctor in the treatment of gender dysphoria ([http://dawn.thot.net/Synthia\\_Kavanagh.html](http://dawn.thot.net/Synthia_Kavanagh.html)). Synthia won the right to her SRS and was moved to a female institution. Though this case was a big leap forward for the rights of transgendered inmates, its ruling is not without flaw. A case by case policy leaves each individual at the mercy of the judge, doctor and prison officials they encounter. This perpetuated the ongoing violation of their human rights.

## **Jail to house transgender men with women inmates**

### **Critic wonders who's paying costs of special panel to evaluate needs**

In a move the Illinois Family Institute suggests is more worthy of a skit on the television show "Saturday Night Live," Cook County Jail in Chicago has instituted a new policy that assigns men and women to cells based on their perceived gender.

The concept that a man believes he is a woman or a woman believes she is a man was in the news just days ago when lawmakers in Maryland considered a bill that would ban statewide "discrimination" based on the gender people feel.

Responding to Cook County's new policy, the Illinois Family Institute said "sexual anarchists" are seeking "to manipulate language in an attempt to convince the public that cross-dressing and elective amputations of healthy body parts are not signs of disordered thinking."

"These rhetorical stratagems must be opposed at every turn, whether they occur in anti-discrimination and anti-bullying laws and policies, comprehensive sex ed, or fatuous, costly jail policies," IFI commented.

Jail spokesman Steve Patterson told WND that the policy was put into use the week it was implemented.

"There was indeed a transgender detainee who came into our custody," he said.

Patterson said the person "had a lengthy arrest record and was unable to post bond while awaiting trial on her most recent charge."

"She had been through some surgical procedures already and self-identified as a woman," he said. "Because of the physical changes and self identity, she has been housed in our female rehabilitative unit, where she has access to existing programs and mental health services," Patterson wrote. "She is housed alone and showers alone, but otherwise interacts with the women in her unit."

Patterson added, "Interestingly, over those three weeks, our staff has noted a dramatic difference in her behavior. She is engaged in regular discussions about traumatic abuses and events in her life and has shown markedly improved change. She indicated it is the first time of her many incarcerations that she was assigned as a female or received any level of counseling or mental health services."

The first confirmation of the policy change came from Cook County Sheriff Tom Dart in an interview with the Windy City Times.

He said the policy was launched March 21 and apparently is the first of its kind in the nation.

"We wanted to do it right," Dart told the newspaper.

He said the policy requires "transgender" detainees be allowed to consult a "Gender Identity Panel" that includes doctors and therapists, and they are not necessarily placed in a cell block that their biological identity would suggest.

He explained the policy directs staff members to allow "transgender" inmates to have clothing and hygiene products that accommodate their gender identity. The policy also mandates that staff members undergo "sensitivity training" presented by the

department.

Laurie Higgins, in a commentary at the Illinois Family Institute, wrote, "So who, pray tell, is footing the bill for the 'Gender Identity Panel' with whom the gender-confused detainees get to consult? And who is footing the bill for the mandatory sensitivity training administered to corrections staff, physicians and therapists?"

Higgins continued, "Here's another pragmatic thought: Does anyone actually believe that women who wish they were men will want to be detained in the men's facility at Cook County Jail? Doubtful. What we're really talking about then is housing men who wish they were women in the women's facility at Cook County Jail. Men who wear women's cosmetics and women's clothing are, in reality, men. ... Why should female detainees have to room with seriously confused men?"

The Times report said Owen Daniel-McCarter, a lawyer with the Transformative Justice Law Project of Illinois, reported his clients had had bad experiences in the jail.

The report noted that Dr. Avery Hart, the medical officer for the company that oversees health issues at the jail, said there are probably two or three "transgender" inmates in the 9,000-population facility at any point.

The report said while San Francisco also recognizes the gender identity issue of inmates, the Chicago policy is unique because it includes the recommendations of the special panel of therapists and others.
